### **4.** Public Comment

C. Hamilton from the South Coast Air Quality Management District (AQMD) made an announcement about upcoming lawn mower exchange events. These events are opportunities for those who still have gas mowers to exchange for an electric mower.

President Messina asked those who had come to comment on Item 7 speak prior to that Item.

5. Changes to Agenda Order: Identify emergency items arising after agenda posting and requiring action prior to next regular meeting
In response to the presenter's request, Item 8 was moved to before Item 7 on the agenda.

#### **PRESENTATIONS**

- Peter Carter, President of PMC, Inc. and Tammy Seale, Project Manager from PMC, Inc. presented the Governing Board with the 2012 Climate Change Business Journal Award for Project Merit: Energy Efficiency for the SGVCOG's Energy Action Planning project. Through the project, 27 participating cities in the SGVCOG received a full greenhouse gas emissions inventory and an Energy Action Plan.
- 7. SCE San Onofre Nuclear Generating Station (SONGS)
  The City of Duarte (John Fasana) declared a conflict and left the room for Item 7.

John King, from Southern California Edison, gave a presentation about the San Onofre Nuclear Generating Station (SONGS) and SCE's efforts to restart the plant. SONGS has not been operating since January 2012, when, during routine inspections, inspectors found isolated areas of tube wear in one of the Units (Unit 2) that operates the plant. Later in the month, engineers also detected a small leak in the other operating Unit (Unit 3). Since that time, SCE and independent experts have been analyzing and repairing the problems. SCE submitted its detailed analysis and proposed plant restart plan to the Nuclear Regulatory Commission (NRC), which will make the decision as to whether and when SONGS can be restarted. SONGS impacts the San Gabriel Valley because, with the reduced energy production from SONGS not being operation, outages could reach the region. In addition, there is a cost associated with this energy, so it is important to use rate-payer resources effectively.

The Governing Board asked several clarifying questions about the safety and process of restarting Unit 2.

8. Southern California Edison Tehachapi Renewable Transmission Project (TRTP)
The City of Duarte (J. Fasana) and La County District (M. Hughes) declared a conflict
and left the room for Item 8.

#### **Public Comment**

Dave Master, from Hope for the Hills, gave a public comment asking for the Governing Board to sympathize and consider the fact that the towers that would be placed for the TRTP were right about their residents' homes and would bring health problems and lower property values. There are many additional costs that are passed on to ratepayers. SCE is just trying to stop cities from standing up to them and to divide the smaller cities.

Irene Udo, from Hope for the Hills, gave a public comment stating that if each California ratepayer were to pay for the undergrounding, it would cost just \$25 - \$50 per ratepayer. If the SGVCOG were to recommend just Chino Hills' homeowners to pay the additional cost, it would be recommending that Chino Hills' homeowners pay between \$22,000 - \$43,000 per household. She encouraged the Governing Board to come visit and see, like the California Public Utilities Commission did when they came to visit and forced construction to stop, how egregious the towers were.

Joanne Jenise, Board member for Hope for the Hills, gave a public comment stating that they supported green energy; however, there needed to be another solution for this project (such as undergrounding the lines). She encouraged the Governing Board to wait before making a decision.

#### **Presentation**

John King, from SCE, gave a brief presentation on the TRTP. He addressed some of the concerns that had been raised during public comment. He also stated some of the potential issues with the undergrounding that SCE was particularly concerned about, including that the underground lines would have to be approximately 100 to 400 feet

underground due to the topography of the area and also that the right of way may have to be expanded by 100 feet. The Administrative Law Judge will make a ruling by June 11, 2013.

The Governing Board asked SGVCOG staff to meet with the City of Chino Hills to get information from them. They also asked staff to confirm the numbers that were provided during public comment, find additional information on whether undergrounding is feasible to accomplish, and research why Russia, China and Europe opted to underground their transmission lines. The item will be brought back to the May Governing Board meeting for action.

# **COMMITTEE REPORTS Transportation Committee**

### **33.** Transportation Committee Monthly Report

J. Fasana reported that the Transportation Meeting held before the Governing Board meeting, there had been a report on the Goods Movement Arterial and also on the status of the 710 North study.

He also gave a brief overview of the Gold Line Eastside Extension Phase 2. The extension of the Gold Line, which currently runs from Sierra Madre Villa in Pasadena to Atlantic Boulevard in Los Angeles, would run to cities further east via one of two alignments: adjacent to the SR-60 and ending in South El Monte or along Washington Boulevard and ending in Whittier. The SGVCOG supports the SR-60 alignment. He stated that the proposed Measure R acceleration could impact when the funds when be available for the project. He stated that environmental analysis of the two proposed routes was currently underway, and comments were being prepared by CalTrans and other agencies. The matter was expected to be back to the Metro Board by the end of the year, with selection of an alternative by the end of 2013 or early 2014.

**34.** MTA Notice to Amend Measure R "Funds Available" Dates

J. Fasana gave a brief overview of the MTA Notice to Amend Measure R "Funds Available" Dates. Metro Staff had proposed a set of requirements that Metro would have to meet to move up the "funds available" date for 5 of the transit projects. Two of

the projects (the Gold Line Eastside Extension Phase 2 and the Regional Connector) are located in the San Gabriel Valley. It is expected to be back to the Metro Board by June.
