Sonia Canchola, from the American Postal Workers Union, addressed the Governing Board about the closure of the mail processing plant in Industry. She commented on the impacts of the closure on mail delivery times and asked the Governing Board to urge the United States Postal Service (USPS) to bring complete mail processing back to the Industry plant.

6. Coordinated Entry System (CES) & Homeless Family Solutions System (HFSS)

Rabbi Marvin Gross, CEO of Union Station Homeless Services, and Ryan Izell, Director of Adult Services, gave a presentation on the Coordinated Entry System (CES) and Homeless Family Solutions System (HFSS) that Union Station was leading and gave an overview of the services that would be provided to homeless individuals and families and how cities could utilize the services being provided. Rabbi Gross encouraged cities that work with homeless agencies to have these agencies reach out to Union Station. There was discussion about Union Station's relationship with the San Gabriel Valley Consortium on Housing and Homeless Services. There were also questions about how housing was identified and whether Union Station would be able to do in-service trainings for staff.

EXECUTIVE DIRECTOR'S REPORT

21. Oral Report

There was no oral report.

22. Annual Dues Calculation

Executive Director Andrea Miller reported the City Managers' Steering Committee had been looking at the current dues structure of the SGVCOG. There had been no changes to the current structure since 2007, and the City Managers' Steering Committee was recommending that the SGVCOG make several changes to the structure that allowed for a gradual increase over time.

This included per-capita dues increase of \$0.02 – from \$0.30 to \$0.32 per capita, an increase in the cap, and annual consumer-price index (CPI) adjustments to address CPI-adjusted increases in the SGVCOG's costs. There was discussion as to whether the dues should include an automatic CPI-adjustment. Executive Director Andrea Miller reported that the SGVCOG Bylaws require 30-days notice before a change in the dues structure. This item would be on the March Governing Board agenda for potential action.

23. Status of Strategic Plan Update

Executive Director Andrea Miller reported that staff would be taking the consultants' work to the policy committees and the draft 2015-16 Strategic Plan would be presented at the April 2015 Governing Board meeting.

24. San Gabriel Mountains Community Collaborative

Executive Director Andrea Miller reported that the SGVCOG had received a request from the National Forest Foundation (NFF) to have a one representative from the SGVCOG serve on the San Gabriel Mountains Community Collaborative. Becky Shevlin, from the City of Monrovia, and Judy Nelson, from the City of Glendora, had previously served on the Committee and wished to continue serving. There was discussion about the process through which the SGVCOG should select a representative. Executive Director Andrea Miller reported that the first meeting of the Community Collaborative would be held on Wednesday, March 4, so there would not be time to go through a formal nomination process and hold a vote prior to that meeting. The Governing Board asked staff to attend the March 4, 2015, meeting of the Community Collaborative. The Governing Board also asked staff to request two representatives on the Community Collaborative.

There was a motion to solicit nominations from all councilmembers in the San Gabriel Valley to serve on the San Gabriel Mountains Community Collaborative and select a representative at the March 2015 Governing Board meeting (M/S: G. Murabito/C. Rosales).

GENERAL COUNSEL'S REPORT

General Counsel Richard Jones thanked Andrea Miller for her leadership during the difficult time for the SGVCOG and the work she had done in building bridges with all members.

PRESIDENT'S REPORT

President Mary Ann Lutz thanked Andrea Miller for her critical role in the SGVCOG's growth over her tenure. She wished her the best of success in the future and stated that she would remain an integral part of the SGVCOG in her new role.

COMMITTEE REPORTS

Transportation Committee

Transportation Committee Vice-Chair Sam Pedroza reported that at the Transportation Committee meeting held prior to the Governing Board meeting, there had been a presentation and discussion on the I-10 ExpressLanes Project that the San Bernardino Association of Governments (SANBAG) was currently exploring. He also reported that there would be a Special Transportation Committee meeting on Wednesday, March 4, 2015, to consider and make recommendations to the Governing Board on the Mobility Matrix and it would be on the March 2015 Governing Board agenda.

Housing, Community, and Economic Development (HCED) Committee

HCED Committee Chair Joe Lyons reported that the Committee was excited that the Coordinated Entry System (CES) and Homeless Family Solutions System (HFSS) programs had rolled out, and the Committee was focusing its efforts on encouraging cities to utilize the CES and HFSS services.

Energy, Environment, and Natural Resources (EENR) Committee

EENR Committee Chair Denis Bertone reported that Edward Beldon, from the National Forest Foundation, would be presenting at the February EENR Meeting, which would be held on Wednesday, February 25, 2015, at 3:00 p.m. at the Monrovia Community Center, on the National Monument Designation and the San Gabriel Mountains Community Collaborative. He encouraged all interested councilmembers and others to attend.

Water Committee

Water Committee Chair Mary Ann Lutz reported that the County of Los Angeles had released a draft Program Environmental Impact Report (PEIR) on the Enhanced Watershed Management Plans (WMPs/EWMPs). These program EIRs would assist cities in preparing their project EIRs for projects that the supported the EWMPs. She also reported that the Committee would be considering legislation carried by Senator Ed Hernandez at its March meeting that would allow the County of Los Angeles Sanitation Districts to assist cities in completing projects that treat stormwater.

PROJECT REPORTS

The ACE Project

ACE CEO Mark Christoffels reported that the Baldwin Avenue grade separation would open on Tuesday, March 3, 2015. He reported that the groundbreaking ceremony for the Fairway Drive Grade Separation Project would be held on Thursday, April 2, 2015.

MS4 Permit Implementation and Funding Efforts

There was no report.

San Gabriel Valley Energy Wise Partnership

SGVCOG staff Marisa Creter reported that the City of Pomona had moved up to Gold in the Energy Leader Model and would be recognized at a Gold Level Celebration on Thursday, February 26, 2015. Pomona Mayor Elliott Rothman thanked the Energy Wise Partnership for its recognition.

California HERO

There was no report.

LIAISON REPORTS

Gold Line Foothill Extension Construction Authority

Gold Line Foothill Extension Construction Authority Vice-Chair Sam Pedroza reported that Gold Line Construction was 85% complete and that testing was underway. The Gold Line Foothill Extension Construction Authority Phase 2B cities were currently discussing artwork for the future stations and public meetings were being held. He reported that the Construction Authority planned to turn operation of the Gold Line over to the Los Angeles Metropolitan Transportation Authority (Metro) in September 2015.

San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy (RMC)

SGVCOG-Foothills representative on the RMC Denis Bertone reported that the RMC would be receiving \$130 million through the Water Bond and was currently determining how the money would be allocated. After that process is determined, the SGVCOG and the RMC will have a workshop to assist cities in accessing that money.

Southern California Association of Governments (SCAG)

There was no report.

South Coast Air Quality Management District (AQMD)

AQMD Boardmember Michael Cacciotti reported that the AQMD would be holding a backpack leaf blower exchange, which would provide professional landscapers with up to 10 electric leaf blowers, worth \$200. He also reported there would be an electric lawnmower exchange in the City of Arcadia.

BOARD MEMBER ITEMS

President Mary Ann Lutz thanked those Boardmembers who were attending their last meeting due to the upcoming elections. It was the last meeting of La Canada Flintridge Delegate Don Voss and Temple City Delegate Fernando Vizcarra. Don Voss introduced his successor Terry Walker, who would be La Canada Flintridge's new delegate.
