7. Potential Los Angeles County Park Ballot Measure

J. Beesley (LA County Park – Open Space District) presented on this item. There was an extensive discussion on local return and equity issues.

There was a motion to recommend that the Governing Board submit a comment letter to the Los Angeles County Open Space District requesting that the following changes be made to the proposed Park funding measure:

- Increase local return to cities to at least 75%;
- Increase flexibility and ease access to local return funds;
- Clarify process for allocation of future excess funds;
- Reduce the set-aside for planning and administration; and
- Consider timing of measure as it relates to other proposed taxes and funding initiatives (M/S: C. Jeffers/ D. Lazzaretto).

M. Christoffels reviewed this item. He indicated that ACE is currently paying down their unfunded liability. However, they have been informed by PERS that they cannot start making payments on their hypothetical termination liability until they actually submit a termination date to PERS. However, they currently have sufficient funds (actual cash, not excess property) to cover their liabilities. ACE is exploring setting up an escrow with PERS to ensure that the funds are protected. The City Managers suggested a trust as an alternative if an escrow is not feasible. Mark will report back in the coming months.
