PRESENTATIONS

- 7. Metro Sustainability Demonstration Project
 - J. Lieb, from Metro, provided an overview of Metro's Sustainability Demonstration Project. Metro will be releasing a call for proposals for Councils of Government, in partnership with their jurisdictions, can submit applications for projects that test ideas from Metro's Sustainability Framework. These projects should include a strong evaluation component and an implementation component, or the project does include plan development, it should have a near-term implementation strategy. He reported that the call for proposals should be released in the next few weeks and is expected to be on the streets for approximately 6 weeks.
- **8.** Affordable Housing & Sustainable Communities (AHSC) Funding Opportunities
 - J. Lieb, from Metro, reported that Metro was looking to partner with any cities that intended to apply for the AHSC program and assist in providing the transportation connection component of the projects. He provided a report from Metro outlining the guidelines Metro would use to evaluate which projects with which to partner. There was a brief discussion on how the AHSC application process had unfolded.

DISCUSSION ITEMS

- 10. Implementation of the Solar Rights Act (AB 2188) SGVCOG staff provided a brief overview of the Solar Rights Act. There was discussion about what cities were doing to comply with the AB 2188. Some ideas included self-certification and utilizing existing policies and ordinances that are already in effect in the cities.
- 11. Implementation of AB 1147 (Massage Therapy Act)
 Cities discussed how they intended to implement AB 1147. Some ideas included developing facility standards, implementing a distance requirement between businesses, requiring a conditional use permit, and implementing a minimum size requirement for massage businesses.

SGVCOG staff provided a brief update on activities at the SGVCOG's policy committees. Staff reported that the Governing Board had recently undertaken its Strategic Planning session; the Transportation Committee was currently working on the SGVCOG Mobility Matrix; the Housing, Community, and Economic Development (HCED) Committee was currently working on assisting Union Station Homeless Services, located in Pasadena, in rolling out the Coordinated Entry System (CES) and Homeless Family Solutions System (HFSS); and the Energy, Environment, and Natural Resources (EENR) Committee was currently working on the National Monument designation for the San Gabriel Mountains.

13. California HERO Update SGVCOG staff directed attendees to the written California HERO Report.

CHAIR'S REPORT

L. Stevens suggested that cities look at revisions to the Federal Communications Act regarding cell phone towers that would limit cities' ability to address the height of towers and the distance from towers.

RE: CAL FIRE LAND USE PLANNING PROGRAM

RECOMMENDED ACTION

BACKGROUND

In 2012, SB 1241 (Kehoe) was signed, requiring cities and counties in state responsibility areas (SRA) and very high fire hazard severity zones (VHFHSZ) to address fire risk in the safety element of their general plans, upon revision of their housing elements occurring on or after January 1, 2014. The update must include consideration of the Governor's Office of Planning and Research (OPR) Fire Hazard Planning Document, specific information about fire hazards, and a set of goals, policies, and objectives to protect the community from unreasonable wildfire risks and a set of feasible implementation measures to achieve these goals, policies, and objectives. Cities or counties must also make the following findings before approving a tentative map or parcel map:

- 1) That the design and location of each lot are consistent with any applicable regulations adopted by the board regarding defensible space requirements;
- 2) That structural fire protection and suppression services will be available for the subdivision; and
- 3) That, to the extent applicable, the subdivision meets the regulations regarding road standards for fire equipment.

Pete Muñoa, Deputy Chief of Land Use Planning for the California Department of Forestry and Fire Protection (CAL FIRE), will be presenting on SB 1241 and the tools and programs that CAL FIRE will be providing to assist cities in meeting SB 1241.

RE: METRO SUSTAINABILITY DEMONSTRATION PROJECT

RECOMMENDED ACTION

BACKGROUND

At the January 2015 Planners Technical Advisory Committee (TAC) meeting, Jacob Lieb, from the Los Angeles County Metropolitan Transportation Authority (Metro), presented on Metro's proposed sustainability demonstration project program. Metro intended to solicit proposals from each of the sub-regions for projects that test ideas from Metro's recently adopted Sustainability Framework. Projects should include a demonstration component, an evaluation component, and/or an implementation component. If the proposal is for plan development, it should have a near-term implementation plan. At that meeting, Metro staff indicated that a call for proposals would be released and each sub-region would have approximately 6 weeks to submit a proposal.

Since that time, Metro staff has contacted SGVCOG staff and indicated that, rather than releasing a formal call for proposals, was asking each sub-region to submit a proposal for approximately \$150,000. Metro staff asked that each sub-region submit its proposal as soon as possible.

Staff has discussed the proposal and is proposing the development of one or two bicycle friendly business districts in the San Gabriel Valley. A BFBD is a partnership between the City, neighborhood and business organizations, and local businesses that improves a business district's bicycle friendliness through bicycle infrastructure and local business promotions to people travelling by bicycle. The district encourages and promotes short, local trips, especially for shopping, dining and recreation.

Several cities in the region have existing "Bicycle Friendly Districts." The City of Long Beach was the first in the nation to develop a Bicycle Friendly Business District. Long Beach's program provides cargo bikes for businesses to make deliveries, and businesses provide shopping and dining discounts on Saturdays to customers that arrive on bicycles. The City of Los Angeles also launched a pilot Bicycle Friendly Business District in northeast Los Angeles, and intends to fund more pilot programs in upcoming budget cycles. The program was identified as a program gol in the San Gabriel Valley Bicycle Master Plan.

Staff is requesting feedback from the Planners TAC on the staff proposal or an alternative proposal to submit to Metro.
