Durfee Avenue Grade Separation Groundbreaking Ceremony

Federal, state, local, and railroad officials gathered on Friday, March 22, 2019 to kick off 30 months of construction of a two-lane roadway underpass and railroad bridge to replace a hazardous railroad crossing on Durfee Avenue in the City of Pico Rivera. The \$105.5 million project, located north of Whittier Boulevard and south of Beverly Boulevard, is part of the Alameda Corridor-East (ACE) Project by the SGVCOG. Construction is projected to create more than 1,370 jobs, with completion scheduled for Fall 2021.

The Durfee Avenue railroad crossing is used daily by 13,600 vehicles and blocked by an average of 49 trains per day. This number is projected to increase to 14,300 vehicles and 91 trains by 2025. The project will reduce an estimated 15.3 vehicle-hours of delay each day.

Durfee Avenue Grade Separation Groundbreaking Ceremony

"This groundbreaking kicks off construction of the 17th grade separation in the \$1.7 billion ACE Projects. These important aspects improve safety for motorists and pedestrians, reduce vehicle emissions and eliminate traffic delays and deadly collisions at railroad crossings in our densely-populated urban region," said El Monte Councilmember Victoria Martinez Muela, Chair of the SGVCOG Capital Projects and Construction Committee.

"Thanks to the support of our funding partners, the ACE program has been a resounding success of the San Gabriel Valley," said City of Temple City Councilmember Cynthia Sternquist, President of the SGVCOG. "The Valley will continue to benefit as we broaden our reach beyond the ACE Projects and help deliver other capital projects to improve the quality of life for our residents."

Construction is underway on two additional ACE underpasses in the City of Industry and the unincorporated community of Rowland Heights. Two final ACE grade separations, located in the unincorporated community of Rowland Heights and the Cities of Montebello and Industry, are seeking funding to begin construction later next year. The ACE Trade Corridor carries 16% of the country's waterborne containerized trade to and from the San Pedro Bay ports. The Port, known as the busiest in the nation, handles 25% of exports and more than 40% of our nation's containerized imports.







SGVCOG Recognized for Excellence in Construction

San Gabriel Railroad Trench Grade Separation Project



Last month, SGVCOG received the 2018 Project of the Year Award from the California Transportation Foundation (CTF) for the San Gabriel Railroad Trench Grade Separation Project. The 2.2-mile project resulted in the lowering of a 1.4-mile section of Union Pacific railroad track in a 30-foot-deep, 65footwide trench through the City of San Gabriel with bridges constructed at Ramona Street, Mission Road, Del Mar Avenue and San Gabriel Boulevard, allowing vehicles and pedestrians to pass over the tracks.

Major construction activities began in Spring 2014, following an extensive archaeological excavation across the street from the historic San Gabriel Mission adjacent to the railroad tracks. The project directly employed 1,211 workers, including 133 San Gabriel Valley residents. The project was completed in September 2018 and the overall cost was \$293.7 million.

Puente Avenue Grade Separation Project



SGVCOG also received a Southern California Chapter 2019 Project Achievement Award from the Construction Management Association of America (CMAA) for the Puente Avenue Grade Separation Project. This 97-million dollar project consisted of the construction of a four-lane roadway underpass on Puente Avenue with a railroad bridge to carry freight trains over Puente Avenue, a separate bridge for Valley Boulevard traffic, and a loop connector road to re-establish the connection between Puente Avenue/Workman Mill Road and Valley Boulevard.

Major construction activities began in June 2015 with the closure of Puente Avenue for underpass and bridge construction. Puente Avenue was subsequently re-opened to traffic in April 2018. The overall cost of this project was \$97.4 million.

SGVCOG Governing Board Adopts Legislative Priorities

The SGVCOG Governing Board adopted the 2019 federal and state legislative priorities at its March meeting. These legislative priorities were developed based on feedback and input from the SGVCOG policy committees and aim to address several of the regulatory, funding, and structural challenges faced by our member agencies.

Water	 Require that capital projects funded with state funds, to the maximum extent reasonably feasible, provide for stormwater capture and dry weather runoff Approach the California Product Stewardship Council to consider developing a tire fee to provide funding to address stormwater pollution Direct the state adoption of financial capability assessment guidelines to better manage compliance timelines for MS-4 permittees
Transportation	 Propose, advocate, and support the development of policies and strategies to ensure potential capital projects applications for funding from relevant federal programs Support legislative or administrative efforts to expedite project planning, development, and delivery Monitor and advocate for legislation or initiatives that would provide additional funding to continue or advance existing funding to priority freight infrastructure projects
Homelessness	 Allocate State funding directly to cities for homelessness programs Support the establishment of a regional housing trust fund Amend definition of gravely ill to include a person's inability to provide urgently needed medical care for him or herself due to a mental disorder

Metro Presents: 626 Golden Streets

Metro is proud to present its 626 Golden Streets that is scheduled to be held on Sunday, May 19, 2019 from 9:00am to 4:00pm. This car-free event allows residents to walk. run, skate, bike, and explore the San Gabriel Valley across five miles of open streets in South Pasadena, Alhambra, and San Gabriel. The streets on the route will be closed to car traffic; however, multiple street crossings will be created to allow cars to pass freely and safely across the event route.

The route, known as "Mission-to-Mission," begins on Mission Street by South Pasadena's Gold Line station and zigzags its way to the San Gabriel Mission at the intersection of Mission Road and Mission Drive. A map of the five-mile route can be found below.

Modeled after "CicLAvia" and other major "open streets" events, the 626 Golden Streets aims to promote sustainable and active modes of transportation, encourage the exploration of San Gabriel Valley's diverse communities, and improve the health of people of all incomes, abilities, and backgrounds. Three major festival hubs will be placed along the five-mile Mission-to-Mission route to provide attendees with places to stop, rest, and relax. Each festival hub will consist of live music performances, game booths, first-aid booths, water stations, portable restrooms, and hand-wash stations.
