

Southern California Gas Overview


- » Serving California for more than 145 years

 - 135 Billion Cubic Feet (Bcf) of gas storage capacity; 3% of US capacity








Natural Gas is Part of a Complex Energy System

Natural Gas Storage


- » Critical element of SoCalGas' gas delivery system serving millions of homes and businesses across Southern California

 - » Honor Rancho serves part of LA Basin
 - » La Goleta serves the northern coastal area
 - » Playa del Rey serves western LA; supports peak demand in LA Basin





Methane Leak at Aliso Canyon

- » Gas leak discovered October 23, 2015;
- » SoCalGas assembled world-class experts to assist with response; seven separate "well kill" attempts performed
- » Relief well drilling began December 4; intercepted target well February 11, 2016
- » DOGGR confirmed well permanently sealed on February 18, 2016
- » Since January 2016 the field has been shut-in. No withdrawals or injections.

RE: ACE/ Large Capital Projects Ad Hoc Committee

This memo describes the creation of the ACE/ Large Capital Projects Ad-Hoc Committee that will examine and advise on the future role of the San Gabriel Valley Council of Governments (SGVCOG) in serving the needs of the San Gabriel Valley.

Background

For the past 18 years the Alameda Corridor East Construction Authority (ACE), which is a subsidiary of the San Gabriel Valley Council of Governments (SGVCOG), has had great success in securing more than \$1.6 billion in funding to construct grade separations to facilitate freight railroad movement through the southern portion of the San Gabriel Valley.

The mission of the ACE project is approaching completion in the next few years, and the SGVCOG must determine next steps. The expertise and excellent reputation of the ACE organization presents an opportunity to address an expanded and new scope of projects, but there are inherent risks and costs with this type of new endeavor.

As part of its Strategic Planning process in early 2016, the SGVCOG Governing Board identified the need to conduct an assessment about the future of ACE and the role of the SGVCOG in planning, funding, and constructing major capital projects. As a result, the SGVCOG president formed an ad-hoc committee with the purpose of studying and fully exploring these issues.

Purpose

The ACE/ Large Capital Projects Ad Hoc Committee is tasked with assessing the future of the SGVCOG and whether it should be primarily a planning agency or should it also have the internal capacity to implement and build large capital projects. A key issue relates to the future of ACE and whether it should close upon completion of its mission or should ACE be reformed and restructured into a large capital project implementation element of the SGVCOG that would be responsible for the planning, funding, and construction of large capital projects in the San Gabriel Valley.

Two alternative future roles should be considered for the SGVCOG:

1) The SGVCOG should focus on being a <u>planning agency</u> that concentrates on assessing the needs of the San Gabriel Valley, developing proposals and plans that address those needs, pursuing grants and funding sources to pay for programs and capital projects, including transportation and capital improvements, and collaborating with appropriate agencies to construct the large capital improvements.

Or

2) The SGVCOG should expand its organizational capacity to become a <u>construction and implementation agency</u>. In addition to planning for transportation and large capital projects, the SGVCOG would take responsibility for managing the implementation of these projects, with the option that the SGVCOG would directly be responsible for building large capital projects. These projects might include new highway construction, bridges, freeway interchanges, and bicycle paths, as well as non-transportation projects (e.g. storm water facilities).

The Ad Hoc Committee may explore variations of these two alternatives in order to develop a recommendation that best meets the future needs of the San Gabriel Valley. In conducting its

analysis, the Committee should consider the costs, benefits and risks associated with each alternative, including the impact on other SGVCOG priority areas (i.e. stormwater, homelessness, and environmental issues). Additionally, the Ad Hoc Committee will review various governance structures, including the formation of a new JPA or revisions to the COG's existing JPA.

The Ad Hoc Committee will conduct meetings, information gathering sessions, discussions with other agencies, including those with and without responsibility for the construction of projects

Schedule

The Ad-Hoc Committee is requested to give a final report to the Governing Board by the end of January 2017 and make interim reports to the Governing Board at each monthly meeting starting in September 2016. It is expected that the Governing Board and the Executive Committee will receive and consider the report of the Ad Hoc Committee during the early months of 2017 and make a decision on the future role and structure of the SGVCOG by late Spring 2017.
